### **POSITIVE PROFIT ALERT**

This announcement is made by B & S International Holdings Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2)(a) of the Rules (the “**Listing Rules**”) Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

Based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the year ended 31 March 2024 (the “**Year**”) and other information currently available to the board (the “**Board**”) of directors of the Company (the “**Directors**”), it is estimated that the Group will record a profit attributable to owners of the Company in the range of HK\$33.0 million to HK\$34.0 million for the Year as compared to a profit attributable to owners of the Company of approximately HK\$27.8 million for the year ended 31 March 2023 (the “**Prior Year**”). The Prior Year’s result included the receipt of a wage subsidy under the 2022 Employment Support Scheme launched by the Hong Kong Government, which amounted to approximately HK\$9.8 million.

Such significant increase in profit was primarily due to (i) the improved revenue and gross profit from the distribution business of the Group in the Year due to the introduction of new products and increased sales of existing products; and (ii) the improved revenue and gross profit from the retail business of the Group in the Year following the improved economy in Hong Kong after the COVID-19 pandemic.

Information contained in this announcement is based on the unaudited consolidated management accounts of the Group and other information currently available to the Board, which have not been reviewed by the Company’s audit committee or audited by the Company’s auditor. The Company is still in the process of finalising the unaudited consolidated results of the Group for the Year and is expected to publish the annual results announcement for the Year on or around 27 June 2024.
